- E) 1.PROHIBITION OF ENTRY INTO CYPRUS TO ANY CITIZEN DUE TO THE CORONA VIRUS PANDEMIC-REGARDLESS OF NATIONALITY- WHO DOES NOT FALL INTO THE FOLLOWING CATEGORIES:
  - I) CYPRIOT CITIZENS.
  - II) LEGAL RESIDENTS IN THE REPUBLIC OF CYPRUS.
  - III) EUROPEAN NATIONALS OR THIRD-COUNTRY NATIONALS WORKING IN THE REPUBLIC.
  - IV) NATIONALS OF COUNTRIES WHO ARE IN A DESIGNATED DIPLOMATIC SERVICE OR MISSION UNDER BILATERAL OR INTERNATIONAL CONVENTIONS.
  - V)INDIVIDUAL CASES OF EUROPEAN NATIONALS OR THIRD-COUNTRY NATIONALS FOR UNAVOIDABLE PROFESSIONAL OBLIGATIONS, PROVIDED THAT THE RELEVANT AUTHORIZATION HAS BEEN OBTAINED FROM THE COMPETENT MINISTRY.
  - VI)EUROPEAN OR THIRD COUNTRY CITIZENS ATTENDING EDUCATIONAL INSTITUTIONS IN THE REPUBLIC OF CYPRUS.
  - 2.ENTRY TO THE REPUBLIC OF CYPRUS IS STRICTLY ALLOWED ONLY TO INDIVIDUALS POSSESSING A MEDICAL CERTIFICATE ISSUED WITHIN THE LAST FOUR DAYS PRIOR TO TRAVEL INDICATING NEGATIVE TO COVID-19 ISSUED BY A STATE MEDICAL LABORATORY OR AN AUTHORISED LABORATORY (SEE LINK AT THE END) BY THE STATE AT THEIR COUNTRY OF DEPARTURE WITH THE EXCEPTION OF
  - A)INDIVIDUALS WHO HAVE TRAVELED ABROAD FOR MEDICAL PURPOSES INCLUDING THE INDIVIDUALS WHO HAVE ESCORTED THEM
    B)ARE CURRENTLY ABROAD ON A SHORT TERM BASIS INCLUDING SHORT TERM STAY OR SHORT TERM PROFESSIONAL REASONS OR SHORT TERM MISSIONS
    C)INDIVIDUALS WHO ARE ENTITLED ENTRY BY THE VIENNA CONVENTION
  - 3.INDIVIDUALS UNDER THE PROVISIONS OF PARA 2(A) AND 2(B) SHALL POSSESS A CONFIRMATION LETTER BY A DIPLOMATIC MISSION OF THE REPUBLICOF CYPRUS AFTER BEARING PROOF OF EVIDENCE SUCH AS AN AIRLINE TICKET OR CONFIRMATION FROM THEIR MEDICAL CENTER
  - 4.AIRLINE OPERATORS ARE ALLOWED TO OPERATE POSITIONING FLIGHTS INTO CYPRUS FOR THE TRANSPORTATION OF INDIVIDUALS WISHING TO DEPART FROM CYPRUS.
  - 5.ALL ARRIVING INDIVIDUALS SHALL REMAIN UNDER QUARANTINE FOR 14 DAYS UPON ARRIVAL AT PREMISES IDENTIFIED BY THE GOVERNMENT OF CYPRUS EXCEPT INDIVIDUALS OF PARA 3(A) WHICH WILL REMAIN RESTRAINED AT THEIRHOUSES TO CONTINUE THEIR TREATMENT.
  - $6.\mbox{NO}$  Entry to the Republic will be allowed to individuals not accepting the aforementioned requirements.
  - 7.AIRLINES SHALL ENSURE STRICT ADHERENCE TO THE ABOVE MEASURES BEFORE BOARDING.
